SPECIAL 3 YEAR MORTGAGE LOAN

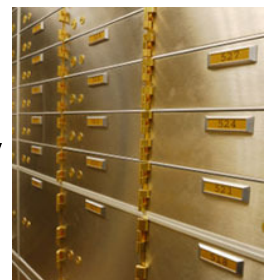

SAFETY DEPOSIT BOX RENEWALS

On May 31st the credit union will be renewing our members safety deposit boxes. All of our members that currently have a safety deposit box with us will receive a reminder notice in the mail prior to the 31st stating that the yearly fee will be debited from their account on June 1st.

If you do not currently have a safety deposit box you may want to consider looking into your options. Safety deposit boxes are a great way to protect your valuables and important documents. There are many benefits to having a safety deposit box including:

- The safety from theft compared to a wall or stand alone safe in one 's home.
The boxes contents can easily be passed on to other family members by signing simple paperwork.
The credit union has one key and the owner of the box the other, so no one person can remove the contents of the box.
The credit union 's safes are fire proof and therefore will protect your valuables in case of a catastrophe
Every time one enters their box we require a signature, so only people allowed access may enter the box.
You may be able to claim the yearly fee for your box on your income tax return.
